

What's Changed | Transaction List

The updated *Transaction List* feature now provides a cleaner, PDF-style report of all transactions—including journals, receipts, invoices, and payments—across any financial year. Reports are now delivered via the *Report Distribution* window for consistent delivery

For working with specific account codes or exporting to Excel, we recommend using *Local Transactions* (per property) or *Global Transactions* (across all buildings), both of which are faster and more flexible for data extraction. Saving these searches too will provide consistent column display and including fields of restriction like *Account Type* for expenses and *Account Code* is any of will provide options for selecting multiple accounts.



Key features include:

- Customisable Settings: Use the cogwheel to adjust sort order, account code ranges, and display of hidden transactions.
- Multi-building Support: Tag multiple properties with the Building Selector Tool.
- Template Options: Choose between (note: letterhead is not supported in these reports):
 - Transaction List (gentran)
 - Transaction List with GST (gentran1)
- Export efficiently using Local or Global Transactions for faster Excel exports and select particular account codes.
